Terms and Conditions:

- 1) The interested parties will register themselves as Royalty Contractors with Director General Mines and Minerals, by submitting an application alongwith registration fee of **Rs.20000/-** non-refundable under head of account C03808, financial soundness, In case of Firm/Company attested documents of partnership deed/Article of Memorandum of association, attested copy of CNIC, in case of already registered contractors for the year 2018-19, will submit applications alongwith renewal fee of Rs.5000/- non-refundable under head of account C03808, alongwith Bank certificate showing the financial soundness of the parties within due date.
- 2) The ex-royalty contractors registered with Erstwhile FATA Mineral Directorate will be registered as fresh. The closing date for submission of registration/renewal applications is 04/03/2020.
- 3) The interested parties will deposit amount of Rs.5000/- non-refundable under head of account as tender form fee.
- 4) Tender forms may be obtained from the Directorate General Mines and Mineral Khyber Pakhtunkhwa (Royalty Section) upto 04/03/2020 till 11:00 AM.
- 5) The tender forms, duly completed in all respect alongwith call deposit shall be submitted on 04/03/2020. The auction proceeding shall be held on the same day i-e 04/03/2020 in the office of Director General Mines and Minerals Khyber Pakhtunkhwa by the Royalty Auction Committee in presence of all participants.
- 6) The interested parties will submit their bid on tender form as prescribed alongwith requisite documents. The bidder in writing can authorize their representatives.

- 7) Un-registered, Defaulter in payment of Government dues and blacklisted will not be issued a tender form.
- 8) The successful bidder will be announced subject to condition that he fulfills the pre-requisite of tender form.
- 9) The successful bidder will deposit 25% of bid money as down payment, 10% of bid money as security, withholding tax, professional tax as per relevant Law and execute an agreement called as "Contract Agreement Pertaining to Collection of Royalty on Mineral" with Director General Mines and Minerals within Seven (07) days, after issuance of offer letter.
- 10) After fulfillment of terms and conditions of offer letter, work order will be issued allowing the contractor to start collection of royalty on Minerals.
- 11) The remaining bid amount will be deposited in Two (02) equal monthly installments from date of work order, failing which the contract will be processed for cancellation subject to (30) days notice will be served upon him.
- 12) The Competent Authority i.e. Director General Mines and Minerals Khyber Pakhtunkhwa reserves the right to cancel the Auction Proceeding as whole or part with cogent reason.
